WHY SHOULD I READ FOR AN INTERNAL BRITISH DEGREE IN SRI LANKA?

WHAT ARE THE PROGRAMMES AVAILABLE?

APIIT-Sri Lanka offers degree programmes in Computing, Applied IT, Business Management and Law. The entire programme can be completed in Colombo and the degrees are awarded by Staffordshire University in the UK. Please see the brochure for course details.

WHEN CAN I JOIN?

Our intakes for Computing, Applied IT and Law are in February, June and October, whilst the intakes for Law are in January and September. Students may register pending results on a conditional basis. You may reserve a place by forwarding your details to info@apiit.lk

HOW MUCH WILL IT COST?

Tuition fees for **all 3 years** (Undergraduate) : \$ 13,500 (variable depending on payment scheme)
Approximate living expenses per annum : \$ 4, 000- \$ 4, 500 (To be arranged by the student)

Estimated living costs include accommodation, food, books, clothing, travel, recreation, etc

WHERE CAN I LIVE?

Overseas students can choose to live, either in Colombo or suburbs and the expenses would vary according to the facilities available.

APIIT Sri Lanka is happy to assist students find suitable accommodation in Colombo. We can also make arrangements to receive foreign students at the Airport.

VISA

You will be notified of the outcome of your application and issued with an Offer Letter enabling you to apply for visa. You are required to obtain an Entry Visa for Sri Lanka. You will have to apply for an Entry Visa at the Embassy / High Commission of Sri Lanka nearest to you.

The Sri Lanka Immigration Department has issued a directive with regard to Visa applications for foreign students. The following guidelines must be strictly adhered to:

- Full attendance is compulsory for all students throughout the course
- Students are expected to pass all examinations and complete the course within the timeframe indicated in the visa
- Students cannot be employed while studying.

DOCUMENTATION

Applicants who have the requisite qualifications for enrolment may register by submitting the following documents together with the Registration Fee. (Photocopies of certificates and NIC/Passport should be submitted along with originals; the originals will be returned.)

- Duly completed Student Registration Form
- Educational and Professional Certificates
- National Identity Card or Passport
- Three passport-size photographs (Please write name and NIC/Passport No. on reverse)

FEES

Registration Fee (non-refundable) : US \$ 300.00
Library Deposit (refundable) : US \$ 200.00

Course fees for the degree programme may be paid up front or in instalments. The course fee includes tuition fee, cost of course materials and assessment and examination fees, but excludes fees payable for any re-sit, external or additional examinations and repeat modules. Students may choose one of the following three payment options at each level:

Payments may be made by cheque in favour of "APIIT Lanka (Pvt) Ltd" or directly to A/C No. 012-000741-001 at HSBC, Union Place, Colombo 2.

Monthly instalments should be paid on or before the 1st of every month. A late payment fee of US \$1 per day is applicable.

Fees for the three year degree programme shall be fixed as above; however, should a student transfer/defer to a later intake/ batch, fee structure of the later intake/ batch will be applicable from the date of transfer.

Instalment schemes are designed for convenience of payment and do not have a direct relevance to course schedule.

REFUNDS

Students planning to withdraw from academic programmes should notify their intentions in writing to the Head, Academic Administration. Refunds of excess payments will be calculated from the end of the month in which actual withdrawal takes place or from the end of the month in which notification is received, whichever is later. The refundable amount will be calculated on a pro rata basis.
